The superintendent or designee will decide what is inappropriate use and his/her decision shall be final.

3. **Privileges** - Since the use of on-line services, Internet providers, and electronic bulletin boards is a privilege, any inappropriate use will result in a cancellation of that privilege. Each individual who receives an account shall be required to acknowledge in writing the receipt and understanding of the rules and regulations appertaining to telecommunicating to out-of-district resources.
4. **Warranties** - The Board of Education shall not be held liable for any damage, including loss of data, as a result of using a telecommunications account.
5. **Security** - System security is a high priority. Security problems shall be reported immediately to the system administrator. Any user identified as a security risk may be denied a system account.
6. **Vandalism** - Vandalism of any part of the telecommunications system, including but not limited to, software and hardware, shall result in cancellation of account privileges, and may result in legal action against the offender(s). Vandalism is defined as any malicious attempt to harm or destroy Board property or data of another user.
7. **Use** - District computers are for use by authorized individuals only. Any unauthorized access to these systems is prohibited and is subject to criminal and civil penalties under Federal laws. Individuals using district computer systems are subject to consents to such monitoring.
8. **Exceptions of Terms and Conditions** - All terms and conditions as stated in this document are applicable to all users on the network. These terms and conditions reflect an agreement of the parties and shall be governed by the policies of the Camden Board of Education, the laws of the State of New Jersey and the United States of America.
